### A Year in Review

With much gratitude, we look back on 2021 as a year that has seen a significant return in safe international travel and cooperation on climate leading up to COP26 in Glasgow. The ICCF Group Caribbean program saw these trends, and immediately got to work ensuring their sustainability at the policy level. The program hosted activities for parliamentarians highlighting opportunities to strengthen sustainable tourism after COVID-19 and promoting naturebased solutions to support climate targets. The program fostered international cooperation for MPs within the global network of conservation caucuses from around the world, regional cooperation through an exciting new memorandum of understanding (MOU) with the Organization of Eastern Caribbean States (OECS), and national cohesion through engaging ministries and agencies on protected areas management capacity. #### **Engagement with Newly-Elected Officials in Saint Lucia**

The ICCF Group organized a project delegation to Saint Lucia in August 2021 to engage with newly elected Members of Parliament and host a parliamentary briefing on nature-based solutions. The delegation included key members of the Caribbean team, as well as Lord John Randall of Uxbridge, Vice Chair of the All-Party Parliamentary Group for International Conservation in the United Kingdom. Lord Randall was an excellent ambassador of the caucus model and initiated numerous discussions on opportunities for collaboration between Saint Lucia and the United Kingdom on conservation issues.

Key outcomes of the mission included a meeting with Hon. Shawn A. Edward, Minister of Sustainable Development, a briefing on naturebased solutions, and a field mission to the Canaries Community Improvement Foundation (CCIF) site of a nature-based solutions case study (pictured below). This CCIF project was funded by the British High Commission and co-implemented by the Inter-American Institute for Cooperation on Agriculture (IICA). The visit included Hon. Wayne D. Girard, Parliamentary Representative for Anse La Raye/Canaries and Minister in the Ministry of Finance, Economic Development and Youth Economy, and helped inform the Eastern Caribbean parliamentary briefing on nature-based solutions.

#### Eastern Caribbean Parliamentary Briefing on Nature-based Solutions

The ICCF Group partnered with the OECS to hold a briefing on nature-based solutions for policymakers of the Eastern Caribbean on August 12, 2021.

Keynote speeches by Hon. Shawn Edward, Minister for Education, Sustainable Development, Innovation, Science, Technology and Vocational Training, Ms. Anya Edwin, President of the Saint Lucia National Youth Council, Lord John Randall of Uxbridge, and Mr. Chamberlain Emanuel, Head of the OECS Environmental Sustainability Division set the context for the event. Panelists from the IICA and the Caribbean Community Climate Change Center (CCCCC) highlighted case studies and brought policymaker attention to actionable practices to support nature-based solutions in their respective countries. The event was followed by a stakeholder roundtable on implementation.

#### Hon. Lennox Linton Attends ICCF Awards Dinner & Subsequent Events with the Global Network of Conservation Caucuses

These included a roundtable on the Commonwealth Blue Charter, a new caucus dinner & reception, and an IUU fishing summit hosted by the United States Oceans Caucus Foundation.

#### **Round Table on The Commonwealth Blue Charter**

The Commonwealth Blue Charter Roundtable with Members of Parliament from Dominica, Kenya, Mozambique, Tanzania, and the United Kingdom was held on September 20th (pictured right). The roundtable was facilitated by the Commonwealth Secretariat, whose representatives gave a briefing on the Blue Charter and its action groups, and answered questions in a facilitated discussion to provide targeted guidance for legislators on opportunities for greater engagement on this global initiative to promote blue economy implementation.

#### **IUU Fishing Summit in Washington DC**

The Oceans Caucus Foundation hosted a Ministerial Roundtable on illegal, unreported, and unregulated (IUU) fishing on September 21st, with participation by Hon. Lennox Linton of Dominica. Topics discussed by the panels included the prioritization of IUU fishing within the U.S. national security strategy, the role of technology in enforcement and monitoring, and the advantages of approaching IUU fishing in a holistic, all-ofgovernment manner, and provided an important opportunity for international collaboration amongst policymakers on this transboundary issue.

## **ICCF IN GLASGOW**

#### ICCF UK hosts Dr. Didacus Jules at side events during CoP-26 in Glasgow

The ICCF hosted Dr. Didacus Jules, Director General of the OECS, to participate in ICCF Group side events at COP26 in Glasgow focused on nature-based solutions, 30x30 initiatives, and opportunities for international collaboration with members from the global network of conservation caucuses supported by the ICCF Group. Key outcomes included the international signing of the Glasgow Declaration, a symbolic commitment by the global network of conservation caucuses and policy leaders to promote nature-based solutions in their respective countries, and the signing of an MOU between the ICCF Group and the OECS.

On November 7th, Dr. Didacus Jules, Director General of the OECS, and Ms. Susan H. Lylis, Executive Vice President of the ICCF Group, signed an MoU between the two organizations to collaborate towards building political will for environmental conservation in the Eastern Caribbean. The signing (pictured below) took place in conjunction with side events during COP26 in Glasgow, and represents the shift to a more regional approach within the ICCF Group Caribbean program.

## **LOOKING FORWARD**

#### **Towards a Regional Parliamentary Forum for Conservation**

In keeping with the MOU between the ICCF Group and the OECS, the project team will present the concept of a regional forum for conservation to the OECS Regional Assembly for input and approval. Such a forum's approval would create an unprecedented body of policymakers from a variety of portfolios and parties in the region to support the implementation of conservation initiatives. It would have the potential to promote consistency through electoral cycles and political changes and ensure that the Eastern Caribbean remains one of the most pristine and biodiverse regions in the world through policy action. The ICCF Group looks forward to inviting our partners and stakeholders to view our presentation to the Regional Assembly in 2022.

#### **A Business Plan for Cabrits National Park**

Technical experts from the ICCF Caribbean project will conduct a field mission to Dominica in February to meet with stakeholders and partners on a business plan for Cabrits National Park. The plan would take into account various costs and revenue streams for the park in outlining a plan for sustainable financing moving forward. This will be conducted in partnership with and at the request of the Government of Dominica.



#### Presenting the Implementation Plan for Codrington Lagoon National Park



Technical experts have been working with Antigua & Barbuda's Department of Environment over the past year on updating the management plan for Codrington Lagoon National Park and drafting an implementation plan to facilitate its application in the park. These plans will be officially presented before the Department of Environment for approval in March.
